RULES AND REGULATIONS

- 1 Dogs entered at Kennel Club Licensed Field Trials must be registered at the Kennel Club in accordance with Kennel Club Regulations for Classification and Registration B.
- 2 In so far as permitted by the Kennel Club Rules and Regulations, the Club reserves the right to refuse any entry for any reason at any time.
- 3 Substitutions may be accepted at the discretion of the Field Trial Secretary. The replacement dog must, however, have been included in the draw.
- 4 All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- 5 If entries or nominations exceed the number of permitted runners, the right to compete in a Trial shall be decided by ballot.
- 6 If an entrant is unable to take up an offered run in a Field Trial, they must notify the Field Trial Secretary immediately by text message, email or telephone, even if they are drawn on the reserve list.
- 7 Any person's withdrawing from a run in the Club's Field Trial within seventy-two (72) hours of the commencement of the stake save where the matters in Regulation J.7.f apply, shall be liable for the full entry fee, even if a reserve is found.
- 8 The club holds all entrants responsible for contacting the Field Trial Secretary in good time before the commencement of the Field Trial if they have not received the results of the draw but were expecting to. As such, if an entrant has been drawn but does not attend the Field Trial or does not withdraw in accordance with the Rules 6 and 7 above because they have not received the results of the draw, the entrant will be liable to pay the full entry fee.
- 9 All persons attending a Field Trial must consider themselves under the control of the Chief Steward, Steward of the Beat, the host (or their representative) and the officials of the club (whether officers, committee members or appointed ad hoc on the day of the Field Trial).
- 10 Should circumstances so dictate the society, in consultation with the judges, may alter arrangements as necessary. Such changes and the circumstances surrounding them will be reported to The Kennel Club.
- 11 No modification may be made to the schedule after publication except by permission of The Kennel Club, followed by advertisement in appropriate journals if time permits before the closing of entries.
- 12 Judges at a Trial are prohibited from entering a dog which is recorded in their ownership or part ownership.
- 13 Videography and photography will only be permitted with the express permission of the Chief Steward and the host.
- 14 Bitches in season must not be brought to the ground in any circumstance.
- 15 Welfare of Dogs - An exhibitor (or competitor) whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any field trial licensed by the Kennel Club. This shall apply at the venue or within the precincts of the trial.
- 16 Dogs in cars on hot days. Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.
- 17 If a competitor, or anyone in their household has Covid-19 related symptoms or has tested positive for Covid-19 they must not attend the event and should self-isolate in line with government advice.
- 18 All attendees at a Field Trial are expected to conduct themselves in a manner which is appropriate and conventional to the shooting field, including dressing appropriately. Jeans, t-shirts and brightly coloured clothing are not acceptable.
