J1.a., 6a(I) and B20)** and if a registered dog has changed ownership the **TRANSFER** must be applied for before the closing of entries. When entering more than one breed or variety, use if possible a separate form for each. On no account will entries be accepted without fees. Use one line of the form for each dog. **PLEASE CHECK ALL DETAILS BEFORE POSTING.** Incomplete entry forms will not be accepted.
