SOUTHERN INTER CLUB TEAM EVENT 2014.

Every year gundog clubs and societies throughout the South of England compete against each other in the Southern Interclub Match. Clubs in the qualifying area are invited to enter a three man team comprising of an open, novice and novice dog/novice handler. The winning team hosts the following year's competition.

The working sub-committee nominated Terry Souter captain and trainer of the Isle of Wight Team and held a try-out at Westcourt for the remaining two places. Members attending club training sessions with a novice dog or novice dog / novice handler were eligible to try-out for a place. Andy Webb, Carole Montague and Corinne Anjo all ran in the try-out which was judged by Terry Souter, Gill Cavaciuti and Wendy Perera. Andy's dog Murphy gave a near perfect performance as did Carole's bitch Jay earning them both a spot in the team with Andy running in novice and Carole novice dog/novice handler.

The team spent the next four weeks training together and getting their dogs used to running out at the same time as the other dogs. Tony Sweatman and Corinne Anjo gave up their time to throw dummies and set-up tests for the team

and by the day of the competition the dogs and handlers were working well together. So far so good!

The competition was hosted by Guildford Working Gundog Club on 29 June 2014 at Windsor Great Park with eighteen teams vying for first place over six tests. The competition was originally conceived in order to provide novice handlers with the opportunity to compete alongside more experienced handlers who could provide them with support and assistance whilst they were under the judge. Guildford drew inspiration from the competition's roots when setting the tests which, apart from one, were a series of three individual retrieves without the opportunity to work dogs simultaneously as had been the case in more recent competitions.

The Isle of Wight Team acquitted itself well earning some good individual scores but at the end of the day Guildford Working Gundog Club came out on top again!

The working sub-committee wishes to thank all those who contributed to getting a team to the competition, not least of all the three team members who gave up a considerable amount of their time in order to represent the Club at this prestigious event. So a round of applause to Terry Souter, Carole Montague, and Andy Webb!

OVER THE RAINBOW BRIDGE

Whether pets, companions or working, living in our homes or kenneled there is absolutely no doubt that dogs leave footprints on our hearts.

We all hope that our faithful companions will have a long life, but for a number of reasons some of us will have experienced the loss of a dog at a young age, dogs that have shown real promise, but have not had the opportunity to shine. There is always something extra tragic about losing a young dog.

This year I have been aware of a number of handlers that have lost dogs, and it is always with great sadness that we read of their loss.

Jan Drake recently lost her lovely pointer Clamerkin Crystal Lace J.W. March 2007 - May 2015

Jan had been at the Bath Championship show where Lace had won her veteran class. She was perfectly well and had shown no signs of illness at all. Jan had been with her all day while she was benched and all was well until bedtime, when she appeared to be in a lot of abdominal discomfort. She collapsed about half an hour later, so she was rushed to the emergency vet, but unfortunately died soon after arrival.

The heartache this has caused Jan is immeasurable. Jan naturally had to have a post mortem, and had to notify the Bath show secretary. No other dogs had been reported ill. Sadly, the post mortem revealed nothing other than the toxicology report, which was negative. Jan's first reaction was to think that something had happened at the show and now at least she knows that there was no foul play. Neither was it her heart that caused her death. There were no other findings.

Jasper, her brother, became ill the next day with stomach problems also, but thankfully he wasn't really badly affected.

Jan has been left unable to draw a line under this awful event. Why did both dogs get ill after the show? Could it simply have been a coincidence, or was it environmental in some way? Jan will never know now.

Lace was a lovely orange and white Pointer. She won 2 CCs, a res. CC and a Junior Warrant. She was usually in the shadow of her brother, but did manage to beat him on occasions. She was first and foremost a beloved pet, very outward going and a natural athlete. Jan could not stop her jumping gates and managing to always be where she was not supposed to be! She would spend all day pointing birds in the paddock.

We all miss the dogs that we have known and lost and those paw prints will always be with us all forever.

HELP STOP PUPPY FARMING

Puppy Awareness Week

From the 1st – 7th September the Kennel Club held Puppy Awareness Week (PAW) 2015.

The PAW survey conducted by the Kennel Club in 2014 shows that a shocking number of people are buying puppies from disreputable sources.

1 in 4 source their puppies on internet sites, on social media, in pet shops or through free ads in newspapers all sources that can be used by puppy farmers

16 percent of pups are bought in pet shops, often used by puppy farmers, and one in five go on to develop the potentially deadly parvovirus

One third of puppy buyers reported not seeing their puppy with its mum and half not seeing its breeding environment. A further 65 percent do not see the relevant health test certificates for the puppy's parents.
